Awards: Club Team award (the top 4 archers from one club following handicap adjustments), Senior Ladies, Senior Gents, Junior Gents and Junior Ladies, after adjustments for handicap (provided in advance). Any archers can shoot, but only those archers with a handicap recorded on the entry form and signed by the Archer's Club Record Officer as correct, will be eligible for an award.

Disciplines: Compound, Recurve, Barebow and Longbow

Rules: GNAS Rules of Shooting will apply
